TERMS AND CONDITIONS

1. Adequate number of buses from Nongthymmai to the Campus and back should ply on all working days.
2. The 'Service Provider' will be informed well in time, if there is any change in the time of running of buses for any reason.
3. Buses should be always in good running condition.
4. In case of any off-road of the buses, the 'Service Provider' has to make alternative arrangement and the University should not be inconvenienced for the same and no extra payment to that effect will be made.
5. Safety and security of the students while transit will be looked after by the 'Service Provider'.
6. Drivers, Helpers engaged by the 'Service Provider' should be well-mannered and disciplined.
7. The payment of taxes to the Government, etc. and any other expenditure towards maintenance of the transport will be done by the 'Service Provider'.
8. A copy of the challan towards the taxes paid to the Government will be provided to the University for record.
9. Both the parties are entitled to terminate the agreement at any time by giving two months' prior notice in writing.
10. All disputes arising out of this Contract/Agreement will be settled by the sole Arbitrator appointed by EFLU, Shillong and the decision by the sole Arbitrator shall be final and binding on both the parties.
11. The agreement shall be governed by Indian law and both the Parties Consent to the jurisdiction of Shillong Courts in all matters regarding the agreement.
12. In case of any non-compliance with the Contract/Agreement Regional Campus EFLU, Shillong reserves the right to impose suitable penalty in proportion to the losses.
